K-State has designed various MAT Secondary tracks built specifically for career-changers like you:

- **License-Seeking Track:** For students who pursue the MAT while continuing their current employment and who will request traditional student teaching.
- **Practitioner Track:** For students who pursue the MAT while teaching full-time. Students apply for a Restricted license after admission.

# MASTER OF ARTS IN TEACHING (LICENSE-SEEKING)

## FREQUENTLY ASKED QUESTIONS

### WHAT IS MAT?

The Master of Arts in Teaching (MAT) opens a pathway to secondary teaching for career changers. Students earn a master's degree and recommendation for a Kansas 6-12 teaching license in agricultural education, English/language arts, mathematics, or social studies OR a Kansas PreK-12 teaching license in modern languages (Chinese, French, German, Japanese, and Spanish). The master's degree combines rigorous online coursework with field experiences in accredited secondary schools convenient to students in the program. Upon completion, students will be able to apply for teacher certification.

### HOW IS THE PROGRAM ORGANIZED?

The secondary MAT consists of two flexible tracks.

- License Seeking track: For students who pursue the MAT while continuing their current employment and will request traditional student teaching.
- Practitioner Track: For students who pursue the MAT while teaching full-time. We help KS teachers obtain a Restricted License.

### WHEN SHOULD I APPLY?

Applications are accepted year-round. Applicants should plan to apply within two to three months from the start of the semester. The fall semester begins in late August, the spring semester begins in late January, and the summer semester begins in mid-May.

### WHAT ARE THE DEGREE AND GPA REQUIREMENTS?

Bachelor's degree with sufficient background in the content field and 3.0 GPA in the most recent sixty credit hours. Each secondary coordinator reviews transcripts (see below). If your GPA is below 3.0, consult your subject area coordinator for suggestions.

### WHAT TESTS ARE REQUIRED?

To be admitted to the program, a student must submit a passing PRAXIS score in the designated subject area [Agriculture (5701), Chinese (Mandarin) (5665), English Language Arts (5038), French (5174), German (5183), Mathematics (5165), Social Studies (5581), Spanish (5195)].

## FAQs CONTINUED

### WILL A KANSAS TEACHING LICENSE TRANSFER TO OTHER STATES?

Yes, Kansas has reciprocal licensing agreements with all other states; however, students may be required to complete an additional test or other state-specific requirements (e.g., state history and/or constitution).

### HOW DO STUDENTS COMPLETE FIELD EXPERIENCES?

Students complete field experiences (practicum and student teaching) in accredited schools near where they currently live. MAT students are required to obtain a device that enables recording, such as a tablet or video-enabled phone. The combination of these technologies enables real-time and video classroom observations and evaluation.

### IS FINANCIAL AID AVAILABLE?

- Kansas Teacher Service Scholarship: Applications are due May 1.
- K-State Online Scholarship: The application deadline is April 1 for the summer, June 1 for the fall, and Nov. 1 for the spring.
- Federal Loan Forgiveness for Teachers: Maximum benefits \$17,500.
- FAFSA: Completing the FAFSA is required to be eligible for several of the financial assistance programs listed above.

### WHAT IS THE PROGRAM COST?

- Tuition is \$570.43 per credit hour.
- 31 credit hours x \$570.43 = \$17,683.33
- Tuition is paid semester by semester or on a monthly payment plan option.

### CAN I CONTINUE TO WORK IN MY CURRENT POSITION?

Yes, for much of the program. However, during the semester you enroll in EDCI 800, you are required to attend your classroom placement six hours per week for 11 weeks for a total of 66 hours; during EDCI 801, you will complete 12+ weeks of full-time student teaching and will not be able to continue full-time employment.

### I AM A PARA-EDUCATOR. WILL MY JOB “COUNT” FOR MY FIELD EXPERIENCES?

No. Although we might be able to place you in the school in which you work, your work as a para does NOT count toward field experiences. Your field experiences require you to demonstrate additional skills beyond your excellent experiences as a para.

Prerequisites. Successful completion of EDCI 702 and EDCI 716 is required prior to enrolling in EDCI 800 Practicum.

Culminating courses. EDCI 801 and EDCI 890 are required during the last semester and are to be taken concurrently.

# MASTER OF ARTS IN TEACHING SECONDARY (PRACTITIONER TRACK)

## FREQUENTLY ASKED QUESTIONS

### DO I NEED TO MARK PRACTITIONER ON MY APPLICATION?

No, students can opt-in to the practitioner track anytime after securing a full-time teaching position.

### WHO WILL SERVE AS MY COOPERATING TEACHER?

Your principal or district HR will assign you a mentor teacher from your building. MAT practitioners are “teacher of record” and serve on a Restricted License.

### IS THE CURRICULUM THE SAME FOR MAT PRACTITIONERS?

Practitioners take the same curriculum as License Seeking Track students. However, Kansas Practitioner's are required to take EDCI 886: Orientation to Teaching to qualify for the restricted license.

### WHERE IS THE BEST PLACE TO SEARCH FOR TEACHING JOBS?

Resources vary by state. In Kansas, the best place to go is [Educate Kansas](#).

### IS THERE A CAP ON THE NUMBER OF PRACTITIONERS?

No.

### ARE PRACTITIONERS ASSIGNED TO A GRADCAT?

Yes, all practitioners are assigned a GradCat who serves as a mentor, evaluator and coach throughout the program.

### AS A PRACTITIONER, AM I STILL ELIGIBLE FOR FINANCIAL AID?

Yes.

### DO I NEED A PASSING PRAXIS TEST SCORE TO PARTICIPATE?

Yes. Secondary Practitioner students need to have a passing PRAXIS score prior to admission to the MAT program.

### IS THERE A TIME LIMIT TO COMPLETE THE PROGRAM?

Yes, KSDE requires students to complete their program within two years of receiving their Restricted license. Once graduated, all MAT students will be eligible to apply for their initial license.

## FAQs CONTINUED

### HOW DO I OPT-IN TO THE MAT PRACTITIONER?

- **Step 1. Admission to the MAT - Register and complete EDCI 702 and 716.**
- **Step 2. Secure a full-time teaching contract in Kansas.** The teaching position must be approved by the MAT Program and KSDE. Positions must be full-time, teacher of record while teaching your MAT content. Search Educate Kansas or local district job boards for openings.
- **Step 3. Contact K-State for Final Approval and Update Plan of Study.** After securing a teaching position, inform K-State that you are selecting the practitioner track. Email or call TJ Duntz ([tduntz@ksu.edu](mailto:tduntz@ksu.edu) or 785-532-5524) to acquire a new plan of study and help adjusting enrollment.
- **Step 4. Enroll in EDCI 886 Orientation to Teaching -** Practitioner track students participate in an intensive week-long professional development prior to teaching that continues with individual support throughout the semester.
- **Step 5. Apply for the Restricted License through KSDE.** The application must be signed by the applicant, school district, and K-State. This will include a background check. EDCI 702 and EDCI 716 must have final passing grades for eligibility. Applicants are required to have a 2.5 GPA in their most recent 60 credit hours of coursework.


